Information

Thank you for taking the time and willingness to participate in the Lethbridge Pride Parade. The parade will take place on Saturday, June 24, 2017. The parade will begin at noon, starting at Lethbridge City Hall. Please meet on the south side of City Hall no later than 11:00 a.m. to be marshalled into your parade placement. Parade Applications MUST be turned into Lethbridge Pride Fest Society prior to being permitted to march in the parade. On Friday, June 23, 2017 at noon the order of parade floats will be announced using Pride Fest's [Facebook page](#) and [website](#). Subject to change at the discretion of the parade coordinator.

The parade route will start at Lethbridge City Hall and head north on Stafford to Stafford to 3rd Ave S, then turn left (west) on to 3rd Ave S and proceed to 5th St S, and then we will turn right (north) on to 5TH St S. We will proceed to 1st Ave S and at 1st Ave S the walking participants will head into the park.

1. The Society reserves the right to approve or reject this Application. If approved, written acceptance of the Application will be sent to you by email at the address identified above. Upon acceptance, further details will be provided to you.
2. Placement in the parade lineup is at the discretion of the Society's parade coordinators. Your lineup assignment will be provided to you on the parade day. Do you have any special requests you would like considered? _____

3. All floats must comply with City of Lethbridge parade guidelines and the Alberta Traffic Safety Act ("Act"). You are responsible for ensuring these regulations are met. We reserve the right to reject the float if the float does not meet the specifications received from the City of Lethbridge or does not comply with the Act.
4. In consideration of the Society allowing the Applicant the opportunity to participate in the parade, the Applicant, its representatives, employees and participants, at their sole and absolute risk, undertake such participation.
5. The Applicant further agrees as follows:
 - (a) To waive any and all claims that they have or may have against the Society, its directors, officers, employees, volunteers and agents (all of whom are collectively referred to as "Released Parties"), arising directly or indirectly from our participation in the parade; and
 - (b) To release the Released Parties from any and all liability for any loss, damage, injury or expense that we may suffer or that any employee or participant may suffer as a result of our participation in the parade, due to any cause, including any wrongful act or omission, negligence, breach of contract or breach of any statutory or other duty of care on the part of the Released Parties.
6. This Agreement shall be effective and binding on the heirs, executors, administrator and assigns of the Applicant.

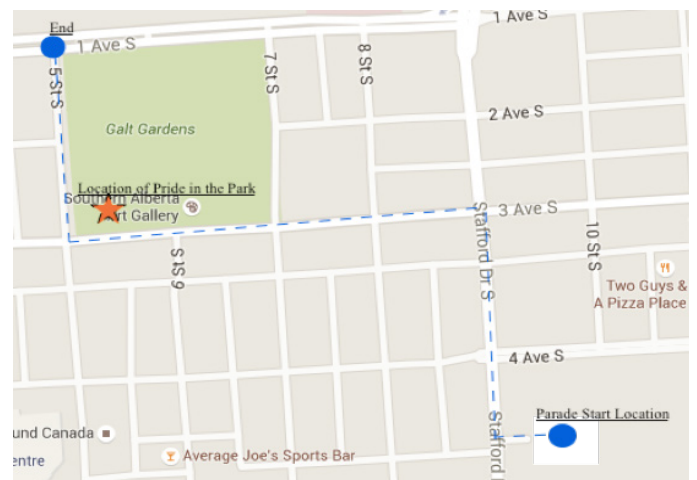
